Permission for reproduction is limited to the applicant and is non-transferable and only for the express purpose described in this application. This permission is non-exclusive; the JHS reserves the right to reproduce the image(s) and to allow others to reproduce the images(s).

In addition to the permission of the JHS, additional permission may be required. In cases of living artists and/or subject to the 1976 Copyright Law or the 1991 Visual Rights Act, written permission must be secured by the applicant from the artist, his/her agent, or the copyright owner and provided to the JHS before a photograph of the artwork will be released.

JHS reserves the right to refuse reproduction of its pictorial images and to impose such conditions as it may deem advisable in its sole and absolute discretion in its best interests.

Unauthorized reproduction will incur a charge of three (3) times the normal fee and JHS reserves the right to demand surrender of all materials containing unauthorized reproductions.

4. **Copyright:**
 - a. In addition to the permission of the JHS, additional permission may be required. In cases of living artists and/or subject to the 1976 Copyright Law or the 1991 Visual Rights Act, written permission must be secured by the applicant from the artist, his/her agent, or the copyright owner and provided to the JHS before a photograph of the artwork will be released.
 - b. **Warning concerning copyright restrictions:**

The copyright law of the United States (Title 17, USC) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, archives and libraries are authorized to furnish a photocopy or reproduction. One of these specified conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship or research."
